Apart from this, 674 textile factories and buying houses were inspected in the fiscal year 2019-20, 1133 in the fiscal year 2020-21, and 1161 in the fiscal year 2021-22, totaling 2968 where Registered buying house In the Ministry of textile is 1165 by June 2022. The intra-policy of state machinery to set up a Buying House Step-by-step preparation is taking standard changes comparatively within the past few fiscal years. ber), Membership of Association (BGBA), and Value Added Tax (VAT) in another form known as (BIN). A pragmatic guideline would be essential to eliminate the stuff of documents such as VAT for buying houses, not a meticulous directive as because they are not the importer or exporter of any commodities as there is no obligatory issue of holding IRC or ERC for mediators. Also, it is not worth extra huge fees to get registration from the Concerned Ministry of TEXTILE where another registration is a topmost criterion called a Trade license from the Principal of the government authority of Bangladesh. (City Corporation) by paying prescribed fees. In the setting of export, it is fundamental for exporters or merchants but for the service supplier or mediators as a Buying agent/house, this essentiality is an inappropriate request which moreover contrasts with govt. approach and concept of doing commerce effectively.

The startup of doing business as a buying agent out of other wings of operation likewise a factory, liaison office, or quality control office is getting critical criteria with the legal procedure by arraying different documents that are somehow contrasting with doing business easy concepts. For instance, registering “Through the Ministry of Textile” is a questionable concern, especially for buying a house, not the entire domain such as factories or country offices or MNC and TNC. Although they are a concerned hierarchy of government authority Firstly Bangladesh bank registration is prime and it was at first done by working precedence because this matter deals with banking laws and regulation for opening and L/C or T/T especially deals with foreign currency but there are other organs of government machinery in Bangladesh

## Case Study

### Case study one.

A textile factory (Dhaka region) submitted their Letter of Interest (EOI) to manufacture export goods ordered from a Dutch company and as a result, a buying agent opened their arms to cooperate with them in transferring L/C to the Factory. Find out in the first export of the merchandise, especially in terms of quality control and assurance, they failed to maintain production mainly in length and width tolerance labels for low consumption, through which they can save free import duty-free fabric to sell the fabric in the local market to get the more unethical benefit. And they illustrate the government department's (UD) counterfeit usage claim. It is not authorized by designated responsibility for the Dutch company to issue an inspection Certificate for each order to provide export permission on this commodity. However, for the greater interest of our country's economic interest in export earnings, and would like to implement this IC actively. Their other sweater maker is processing their order from an allocated Dutch company and their manufacturing assets are not in the brand but are under consideration. The factory then discriminated against one of the items they ordered (a sweater) in different ways, fined the buying unit about \$75,000, of which their service commission was seized, and eventually the agreement (MOU) with the Dutch company was canceled. After investigation, found that the factory had taken the wrong initiative to many extents of operation. The most wondering issue is unbearable in the sense of business ethics when the Dutch company presented the claim officially they hid themselves. Eventually, the buying houses were losers and lost the buyer's faith.

**Case study Two-A woven factory (Gazipur location).**

Nominated by a buying agency to do random work for manufacturing DENIM and Shirts and Padding Jackets with their best internal and external procurement and workmanship with business ethics. The said Dutch principal was quite happy to receive such merchandise and several times physical presence of a Dutch principal took place here in Bangladesh. When the factory started its business journey with the buying agent that factory was a small size industry but after running with their orders the unit was raised and extended the production space. Thanks to all that through the intermediaries of buying agents the factory's targeted economy was broadened. Suddenly they failed to cope with their given lead time problem which caused disputes. So far the owner was honest and ethical in many ways of doing business for the length of 2012 to 2019 but suddenly the Dutch company reformed their family business with a separation strategy on product segregation brands. Noticed by their direction that The said buying agent was entitled to work with only one stakeholder out of two and his products and the said stakeholder was not willing to work with the same agency and suggested the quality assurance personnel to work with him by creating an innovation. During that period the personnel had no individual entity for this role to play in business therefore discussed with the owner of that factory the said issue of transferring L/C directly from the Dutch Company and as an arranger and as an inspector. Finally, the ETHICS is questioned for their direct interaction with the Dutch buyer where the avoidance and strategy were taken. In the end, the fabrics supplier who did the job from the beginning still engaged to serve the shell fabrics and spoke the inconvenient truth to the buying agent Saying that your faith is unjustified on the ethics and therefore abstinence on trade benefits. However, still, trust is still alive for the existence of human behaviors. Who broke the business ethics either buyers or garments is a question to judge?

**Case study Three (Narayngonj belt)**

Focusing on "a knit factory" that is located in Narayanganj also worked with the same buying agent for a length of six years for the production of our knit items of the said Dutch buyers and the buyers also visited the factory and were satisfied with the quality of workmanship. The buying agent felt good running with the industry though their price is much higher in comparison with other garment factories. Although they have no discrimination from their production due to extreme greed some of their management and merchandisers personnel tried to hack our principal through any means of backbite for getting orders directly through offering the lower price. In the end, our buyers are hacked and executed in direct order for their interest where the ethics of buyers as well as the factory is questioned.

**Case study four (Dhaka location)**

To get rid of sorrows after a length of 2 years the said buying agent found a small factory located at Dhaka Uttar Khan are keeping their business ethics first though this is highly tough in this domain but their dream is not big enough to enlarge their factory. Just doing business for survival and sustenance. Quantita-

tive research has been applied to several 50 factories to find the keeping nod of business ethics there (3 out of 4) factories is not taking business ethics into their accounts. So the real scenario of garment factory's data of unethical exercise is almost 75%. That is alarming for future business anthropology.

However, ethics is concerned, at present Bangladesh remains the third biggest attire source for the Joined together States in 2022 with a 9.75% share of its add-up to attire consequence, which was 8.76% in 2021, said BGMEA President Faruque Hassan in a later letter to its individuals and colleagues. In 2022, the US's clothing purport from Bangladesh developed by 36.38% year-over-year. The US imported \$9.74 billion worth of attire from Bangladesh in 2022 which was \$7.16 billion in 2021 and \$5.40 billion in 2018, the letter said. The US is one of the major attire merchants for Bangladesh as well as for the world. A slide introduction highlighting the sector's current condition appeared at the meeting of USA Officials maintained a strategic distance from commenting on the political circumstances and commended the steps taken to move forward work conditions. BGMEA personnel were working on understanding issues at the industrial facilities. Claimed there were exchange unions at 293 production lines and they would be set up at other industrial facilities. The periodical observation 2015-2018 by the in-charge honorable personnel of the USA in Bangladesh said the USA would proceed to help the BGMEA in coming to its \$50 billion send-out target. She watched that more changes were required to move the Bangladesh RMG segment forward and guaranteed her government's bolster. As of now, the political distress has cast a negative effect on a piece of clothing producers, as the number of BGMEA individuals has come down to 4222 from 5876 and the wiped-out industry list has longer to 439 from 279.

nam remains within the moment position. The value of US clothing from Vietnam was \$12.21 billion in 2018 which expanded to \$14.37 in 2021 and came to \$18.24 billion Times. BKMEA said their part companies took UD's for 6.30 billion pieces of attire, which had a send-out esteem of \$13.90 billion within the 2022-23 monetary, and UD's for 8.29 billion pieces of attire, which had an send out value of \$17.33 billion within the past financial. Meaning the net trade of attire fell by 23 percent and earnings by 20 percent. Other than that, BGMEA said it provided 22,352 UD certifications within the 2022-23 financials and 24,794 UD's within the 2021-22 financials. This implies issuance of UD's fell by 10 percent within the final financial. Profit of the weave manufacturing plant, Plumy Styles Restricted in Narayanganj, from attire trade diminished by 10 - 12 percent and the sum of export by 12 - 15 percent within the 2022-23 monetary. Overseeing chief Fazlul Haque said, "Since our company delivered the premium fragment of attire, our circumstances are that terrible. Send out of numerous other manufacturing plants diminished more, work arranged too fell.

On the other hand, the cost of cotton has also diminished. As a result, it is

abnormal that send out of attire fell.” Alps Apparels Bunch works in two industrial facilities within the Zirabo region of Ashulia. The Gather sent out apparel of \$30 million within the 2021-22 monetary, which fell by 30 percent to \$21 million within the 2022-23 monetary.
